Should such an exchange or trade take place, Broker is permitted to represent and receive commission from both parties. During the listing period, should the "Home" be sold by the Broker, by the undersigned, or someone else: or should the Broker produce a buyer ready, willing and able to purchase the "Home"; or within a three (3) month period after the listing's expiration date, a sale is made to any person to whom the "Home" was shown during said listing period by the Broker, the undersigned or anyone else, the undersigned agrees to pay the Broker a commission of _____% of the sale price but not less than \$_____ in the event of a sale, the undersigned agrees to convey the usual transferal documents for a marketable title. The undersigned also agrees to deliver all documents needed for closing and to execute those documents necessary for the transfer of ownership and closing of the sale.

3. The Broker is authorized to place "FOR SALE" signs on the "Home" and remove all other "FOR SALE" signs from it. The Broker is also authorized access to the "Home" for the purpose of showing it to prospective buyers. Said showing to be at acceptable and reasonable hours.

4. The undersigned represents that they are in peaceful possession of the "Home" and that they have a clear and marketable title subject only to the below noted lien(s) and/or obligation(s).
